TRADE NOTICE

Sub: Amendment to the coastal concession policy.

Tariff Authority for Major Port (TAMP) has passed their order on 5th October 2015 on the subject proposal. The order has been notified in the Gazette of India Extraordinary (Part III Section 4) on **19th October 2015 vide Gazette no. 351.**

Vessel related charges for coastal vessel will take into account the exchange rate fluctuation of Indian Rupee v/s US \$ so that the same shall not exceed 60% of the corresponding charges for other foreign going vessels.

Container related charges which are denominated in US dollars for the foreign containers, the tariff for coastal container will not exceed 60% of corresponding charges for other foreign containers.

The schedule of vessel related charges/Container related charges, rates prescribed for coastal vessels/containers handled will be replaced as follows:

1. Rate for coastal vessel is up-to 60% (of the rate for foreign-going vessel juxtaposed) calculated by taking into account the exchange rate fluctuation.
2. Rate for coastal container is up-to 60% (of the rate juxtaposed) calculated by taking into account the exchange rate fluctuation.

Both vessel related charges and container related charges will be collected in Indian Rupees **for coastal vessel/containers.**

The above rate will applicable w.e.f. 1st November, 2015.
