TRADE NOTICE

Tariff Authority for Major Ports vide its order dated 4th April 2014 revised the scale of rates vide Notification G. No.137 dated 19th May 2014 providing for 12% increase in Marine related charges and 40% increase for Bulk and Cargo related charges and marginal higher increase in certain miscellaneous tariff item. The details of revised scale of rates is available in the Annexure II of the Notification issued by TAMP and hosted by TAMP on their website www.tariffauthority.gov.in. As stated in the order, the revision to the scale of rates will come into effect after expiry of 30 days from the date of issue Notification of the Order in the Gazette of India i.e. 18th June 2014.

It is to clarify that since the revised rate will come into effect from midnight of 17th June 2014, all vessels which are berthed upto 2400 hrs of 17th June 2014 shall attract Port Dues and Pilotage at old rates and for berth hire beyond 2400 hrs of 17th June 2014, new rates will apply since it is on hourly basis. In case a vessel arrives on 15th or 16th June 2014 and stays beyond 17th June 2014, berth hire for actual number of hours upto 2400 hrs of 17th June 2014 will be levied at old rate and thereafter at new rates. Similarly in respect of container handling activities performed, all vessels which arrive upto 17th June 2014 and stay beyond 17th June 2014 will be charged at old rates for import cycle and revised rates for export cycle. Vessels which arrive on or after 18th June 2014 will be charged at revised rate for both import and export cycle. In respect of dwell time charges, for dwelling period upto 2400 hrs of 17th June 2014 old rates will apply and for period beyond 17th June 2014 new rates will apply.
