### TRADE NOTICE

In continuation to the Trade notices dtd. 02.04.2020 and 21.04.2020 issued by JNPT, the following waiver/remission/relaxations are extended by JNPT during Lock-down Period ie from 22.03.2020 to 03.05.2020 plus 30 days recovery period in line with directives received from Ministry of Shipping vide letter no: PD/14033/4/2020-PD VII dtd. 21.04.2020 for JNPCT:

- No dwell time charges will be levied for all import / export containers moved by Road and Rail (CFS/DPD/Empty/ICD) ie gated-out / railed-out / loaded on board.
- No shifting charges will be levied for change of mode (ie Truck to Rail or Rail to Truck).
- No shifting charges will be levied for DPD-DPD containers moved by Rail after 48 hrs to ICD Mulund or ICD Tarapur as they are declared as 'extended Port gates' of JNPT.

The aforesaid relaxations should not impact or dilute the day to day operations and evacuation of containers from Terminal.

Accordingly all stake holders shall make efforts to continue operations in all respects in true spirit of the above guidelines by the Government and ensure to pass on the benefit of the above relaxations to the end users.
