TRADE NOTICE

Sub: Tariff Revision of JNPT

Last Tariff Revision order was passed on 4th January, 2017 by TAMP and notified in the Gazette of India Part- III Section 4 on 24th January, 2017 vide Gazette No. 29. The revised scale of rates and conditionalities came into effect after expiry of 30 days from the date of notification of the order in the Gazette of India and due for revision.

Meanwhile, as per directions of Ministry of Shipping, TAMP had notified tariff policy for Major Port Trust for "Policy for determination of Tariff for Major Port Trusts, 2018" vide Gazette Notification No.17 dated 16th January, 2019. The working guidelines notified by TAMP vide Gazette Notification 29 dated 30th January, 2019 are applicable to all Major Port Trusts and came into effect from the date of implementation of the Tariff Policy, 2019.

As per this new Tariff Policy, 2019 all Port Trusts are required to assess their Annual Revenue Requirement (ARR) which is the average of the sum of actual expenditure as per the final audited accounts of the three years commencing from 2015-16, 2016-17 and 2017-18 plus return of 16% on capital employed including Capital Work in progress as on 31st March 2018. It requires that ARR should be duly certified by practicing Chartered Accountant or Cost and Management Accountant.

In accordance with the above, the Port has carried out the computation for revised tariff and in accordance with ARR (after taking into account the working guidelines) and the proposal has been submitted to TAMP. As per the same, the following increase in tariff is arrived at:

1	Bulk other than liquid	22.56%
2	Container related Charges	22.56%
3	Vessel Related Charges	19.03%
4	Liquid Cargo	22.56%

Draft Scale of Rate and the proposed Performance Standards are also enclosed herewith.
